**Fee: \$40.00 per space for one day and \$70.00 per space for two days postmarked on/before March 10, 2012.** For contracts postmarked after this date the cost per space is \$75.00 for one day and \$150.00 for both days.

**Set-up time:** 11:00 a.m. to 12:30 p.m.

1. Vendor spaces are allocated by date applications are received and will be assigned in same order.
2. If we cannot accommodate your operation, a full refund will be returned to you. If you need to cancel, your fee will be refunded provided the space can be rented to another vendor. If you do not show the day of the show, you risk losing your spot the following year. Fees will not be refunded for cancellations after March 10, 2012.
3. Crumland Farms reserves the right to refuse sale of merchandise that is deemed, in their discretion, to be unacceptable. This includes real or toy firearms and alcoholic beverage related items.
4. The vendor is solely responsible for collection and payment of any Federal, State, or local taxes, including Maryland sales tax.
